Update: Work Begins on 459 Granite Street!



459 Granite Street

onstruction has begun on this blighted property on Manchester's West Side, part of our West Side RENEW project. Marked with a red "X" by the City of Manchester and uninhabitable for the past number of years, this property is in the process of transformation, ultimately yielding a total of 4 new units of affordable rental

housing for working individuals and families. Built just before 1850, the building has a strong structural core. Work completed to date or in process includes: demolition of hazardous materials, temporary heat and power installed; demolition of interior to the studs; removal of two of four existing chimneys; removal of existing roof and replacement with new roof; reinforcement of

West Side RENEW will include the rehabilitation of an additional 7 units on Douglas Street thanks to the investment and resources from the City of Manchester and contributions by New Hampshire's business community that includes Brady Sullivan Properties, Eastern Bank, Lavallee Brensinger Architects, TFMoran, Tidewater Catering, Trivantus, Gary Chicoine Construction, Cambridge Trust through the New Hampshire Community Development Finance Authority. structural components, including floor joist and walls; framing of new roof structure for back

staircase; interior wall framing; and removal of exterior siding to sheathing.

Our presence in the Nashua region began in 2013, as we moved forward on the completion of Hidden Pond Apartments, a twenty-eight unit affordable rental development in Amherst; the acquisition of a total of 42 existing affordable rental units in Nashua, which included one 28-unit development and five scattered site locations in downtown Nashua that totaled 10 units; and delivery of homeownership education seminars.

Our team began working with City of Nashua leaders and other community members to identify the most pressing revitalization needs in the City. The Tree Streets neighborhood emerged as a priority, and since this time staff and volunteers have spent considerable time in the area, surveying residents and other stake-

holders and hosting a variety of programs and events, all toward building relationships with residents and other stakeholders to better understand issues and develop strategies to help move this neighborhood forward from a social and structural perspective.

The ground work our Community Building and Engagement efforts have laid brought us to the launch of our current investment in the Tree Streets neighborhood where our goal is to improve housing stock, create new housing opportunities, and reduce the number of dilapidated or deteriorated properties. Our investment began with the purchase of a six-unit property located at







38.5 West Hollis Street

4-14 McLaren Avenue and a 2-family 4property located at 48 Ledge Street.

This acquisition focus was expanded upon with the purchase of 40 Pine Street, an empty lot at the end of the Broad Street Parkway, 38.5 West Hollis Street, and 40 Ash Street. Redevelopment will extend over the next several years, resulting in an estimated investment of more than \$2 million in the Tree Streets neighborhood.

We appreciate the generous response from New Hampshire's business and philanthropic communities whose financial support is helping to make positive change happen in the Tree Streets neighborhood. Stay tuned!

Felix Torres Colon

Executive Director Manchester Neighborhood Housing Services 1996 – 2004

e were saddened to learn of the passing of Felix Torres Colon in early February. Felix was the Executive Director of this organization from 1996 to 2004 when we were known as Manchester Neighborhood Housing Services. Felix was part of the NeighborWorks[®] America (Neighborhood Reinvestment Corp.) team that came to Manchester in the early 1990s to work with community leaders and residents, developing a plan to address deteriorating conditions in Manchester's Center City neighborhood, which was overridden by rundown buildings and dilapidated housing, low homeownership, and openly illicit behavior on the streets.

Felix was an engaging, warm, and humble individual, deeply committed to improving conditions in underserved neighborhoods, including housing conditions for those with the least financial resources and opportunities. He had served most recently as Executive Director of New Kensington Community Development Corporation in Philadelphia, another NeighborWorks[®] America chartered organization, dedicated to housing needs in that region.

Felix acknowledged that risk taking was essential in the early days in order to begin to open doors for quality housing and neighborhood improvement needed in Manchester's Center City. We continue that motto today – "no risk, no housing." He worked tirelessly, recruiting residents and community leaders and securing resources

to address issues and needs in the neighborhood. In addition to leading efforts to redevelop rundown properties into new affordable rental units, demolish a former crack house and create a public park in its place, and shut down a notorious bar in the neighborhood, Felix led the organization in establishing homeownership education and lending services, and then developing affordable rental housing in other Manchester neighborhoods, including the brownstones located on the north end of Elm Street.

Felix's impact on Manchester continues to be seen and felt today. He cared about others and it showed in the work he did in our community. He is an example of how a person can make a difference in the lives of others. Rest in peace, Felix Torres Colon, and thank you.
